Duke-Durham Neighborhood Partnership -

- Update of grant opportunities \$2,500 on our own, and \$10,000 partnering with another non-profit
 - \$1400 for bronze plaques
 - \$1100 for maintenance of Watts School rain garden, which will probably involve a community work day as well
 - The \$10,000 involves joining with a non-profit and the Ellerbee Creek Watershed Association has asked if we are interested:
 - Funding for invasive species management along the trail
 - Developing interpretive material about the natural and cultural history (putting in a sign, etc.)
 - Develop and establish signs to encourage people to explore the trail.
 - Many ideas were discussed, but most would take time to develop and the timeline here is the next couple of weeks.
 - So we are going ahead with ECWA
